# **01** CHAPTER

## The Academy





#### THE ACADEMY

The Indira Gandhi National Forest Academy (IGNFA) was established in 1987 and is distinguished as the premier institution in India for training officers in the Indian Forest Service (IFS). It succeeds the former Indian Forest College, established in 1938.

With a persistent commitment to its mission, IGNFA imparts professional training to IFS Probationers and holds the esteemed status of a Staff College, offering Mid-Career and In-Service training courses for IFS officers.

Located in the serene surroundings of the New Forest campus, approximately 5 kilometres west of Dehradun's city centre, IGNFA shares its grounds with the Forest Research Institute (FRI), further enhancing its academic ecosystem.

Spread across nearly 1100 acres; the Sylvan New Forest-FRI Campus boasts diverse landscapes encompassing natural forests and dense experimental plantations. The Tons River borders the campus to the north and the Chakrata Road to the south, which provides an ideal immersive learning and research setting. Situated at 670 metres above mean sea level, the campus benefits from an abundant annual rainfall exceeding 200 cm, nurturing an environment conducive to studying forests and their management.

#### **Organizational Structure**

IGNFA is under the administrative control of the Ministry of Environment, Forest & Climate Change (MoEF&CC), Government of India (Gol). It is headed by the Director, who is in the rank of PCCF (Head of Forest Force). The Director is assisted by one Additional Director, two Professors, six Additional Professors, six Associate Professors, and the office staff. The list of faculty members and staff is appended in Annexure I. The administrative functions assigned to the faculty members are given in Annexure II.



#### Mandate

The Academy's mandate is to impart professional training to the IFS Probationers and help them develop competence for sustainably managing the country's forest and wildlife resources. It also enables them to act as agents of environmental protection, economic development, and social change.

The capacity-building programmes include training new entrants to the service, In-Service Training (Mid-Career Training Programme) for contemporary batches of IFS officers, and a Professional Skill Upgradation Course (PSUC) for officers inducted into the IFS upon promotion from the State Forest Service (SFS). The Academy also provides orientation courses to various other stakeholders, such as officers of other All India Services and Central Services, members of the higher judiciary, and others.

Considering the challenges forest officers face in managing the most valuable and life-supporting resources, the Academy makes all-out efforts to professionally equip them with the required skill sets. Further, much emphasis is also placed on developing values like integrity, empathy for the underprivileged, ethical values of public governance, gender issues, etc., to groom the Probationers as professionals of this elite service.



**Facilities** 

Classroom sessions are held in the main building, equipped with lecture theatres, a conference room, a computer lab, a bioscience lab, a geomatics lab, a wildlife lab, faculty rooms, and a reprographic unit.

Probationers stay at the New Hostel and the Old Hostel on the New Forest Campus, while In-Service officers are housed at the Executive Hostel. These facilities have mess services and sports infrastructure, including a billiards room, badminton court, table tennis hall, lounge area, and modern gymnasium.

Additionally, the Academy has a spacious playground adjacent to the New Hostel complex for physical training and outdoor recreational activities. Complementing this outdoor space is a contemporary pavilioncum-indoor sports complex overlooking the playground, featuring a multi-gymnasium hall, billiards and table tennis facilities, a physiotherapy centre, and a seating area accommodating up to 200 individuals.

Adjacent to the New Hostel, the Academy has the 'Hari Singh Auditorium,' which has a seating capacity of 600 and is utilized for hosting cultural and academic events. Furthermore, a Guest House is available to accommodate visiting faculty members.

A residential complex designated for IGNFA faculty and staff is opposite the FRI campus on Chakrata Road. The New Forest Hospital, operated by FRI, offers medical services catering to outpatient and inpatient needs. Additionally, essential amenities, including a Post Office, Bank, and ATM, are conveniently accessible within the campus premises. Significant enhancements have been made to the sports infrastructure in recent years. These include incorporating modern facilities such as synthetic basketball and volleyball courts, an upgraded squash court, a well-equipped gymnasium, and a dedicated badminton court to supplement the pre-existing sporting amenities.





A new addition to the campus amenities is the recently inaugurated all-weather swimming pool named Pandit Deendayal Upadhyay Swimming Pool, spanning 25 meters in length and 21 meters in width, unveiled on April 28, 2022. This facility serves as a valuable resource not only for the Probationers and faculty of the Academy but also for their families and



IFS officers stationed within the FRI campus. It provides a conducive environment for recreational activities, physical fitness, and relaxation, contributing to the holistic development and well-being of the community within the campus.

#### **GLIMPSES OF FACILITIES AT IGNFA**

#### **GIS Lab**

The IGNFA has a state-of-the-art Geomatics Lab with about 55 computers equipped with the latest Digital Image Processing (DIP) and Geographic Information System(GIS) software, Erdas Imagine and ArcGIS.

#### **Information Technology**

During the past year, the Academy has significantly improved its infrastructure, ensuring optimal functionality and efficiency. These enhancements include installing, testing, and commissioning a digital audio system in the Platinum Jubilee Hall, Pine Hall, and Deodar Hall. Additionally, a 6k lumens laser projector has been installed in the GIS Lab, providing enhanced visual experiences for the Probationers and Faculty. Furthermore, the Academy has renewed the antivirus software for 440 desktop computers and laptops for three years, utilizing the Government e-Marketplace (GeM) for a seamless process. In line with commitment to sustainability, the Academy has replaced 30kva UPS batteries through a buyback policy. The Cisco Webex suite has also been renewed to facilitate smooth hybrid and virtual meetings. Moreover, the Academy has renewed care packs for Cisco hardware, including 49 access points and 15 core switches, ensuring efficient operation for the next two years. Significant upgrades have been made to the networking infrastructure of the GIS lab, with the installation of OFC cables resulting in a significant speed increase from 100 Mbps to 1 Gbps, facilitating improved performance and productivity. These infrastructure enhancements demonstrate the Academy's ongoing commitment to providing a state-of-the-art learning environment for the probationers.

In addition to the activities above, the Academy's I.T. cell has outlined several crucial tasks scheduled for the upcoming fiscal year. Firstly, the Academy plans to conduct a security audit for its website and related portals. The audit is necessary to ensure compliance and security.



Further, network upgrades are planned to enhance and expand the Academy's I.T. infrastructure, accommodating growing I.T. requirements and ensuring users' stable, high-speed connection. The current networking infrastructure, including core switches installed in various buildings, is limited to a maximum speed of 100 Mbps, despite the Academy receiving an internet connection from the ISP with a speed of 1 Gbps. Additionally, considering the rapid advancements in technology and cyber security threats, the Academy is

considering replacing or upgrading its existing Sophos XG 330 firewall to ensure the network and data remain protected against evolving cyber threats and vulnerabilities.

IGNFA Library is fully computerized. The library has a rich collection of nearly 37,500 resources in various disciplines. The resources include books, bound volumes of journals, State-wise materials, maps, reports, slides, audio-video cassettes, compendiums etc. Besides these, almost 71 periodicals, popular magazines, and newspapers are on the regular subscription. Eight online journals, five e-newspapers, and BioOne's complete package of 205 online journals are subscribed to the library. Procurement of the latest books on various forestry subjects and other allied sectors is a priority for the Academy. The library also has important encyclopedias and dictionaries on different subjects. The IGNFA Library has purchased web-based software like LIBERTY Management Software. New software modules, such as acquisition, periodical indexing, Web OPAC, SDI, indexing and abstracting, and multimedia, are functional in the library. Relevant e-books and daily newspaper clippings are uploaded on the library website. Many new books and journals were acquired during the library's financial year 2022-23. IGNFA Library has developed webpages for online journals, enewspapers, e-books, compendiums, institutional repositories, and other materials.

The services and facilities provided by the library are:

Faculty members, IFS probationers, and participants of inservice courses, including the Skill Upgradation Course, liberally use the library resources. Study material compendiums in separate sections are kept in sufficient numbers and uploaded on the library website. Reference and State-wise materials are displayed in a separate section.



#### **Book Exhibition**


IGNFA Library is in the process of enrichment by adding new books from various subject fields. The IGNFA Library organized book exhibitions in October 2022 and January 2023. Different suppliers were invited to display the latest publication of various forestry-related books. Faculty members, IFS Probationers, and CASFOS Faculty and trainees visited the exhibition. They selected the latest books on Wildlife, Silviculture, Forest Management, General Management, Biodiversity, Medicinal Plants, Joint Forest Management, Sustainable Development, Forest law, Rural Development, English Fiction and non-fiction and Hindi discipline of renowned authors and publishers for purchasing in the library. The Library procured the selected books and displayed them in the new arrivals section.













#### Professional Training Courses for IFS Probationers

The Indian Forest Service (and not Imperial Forest Service) recruitment dates back to as early as 1870s which was later reconstituted as an All India Service in July 1966 under the All India Services (AIS) Act, 1951. Direct recruitment to IFS is based on an annual competitive examination conducted by the Union Public Service Commission (UPSC). The officers appointed to the Indian Forest Service undergo Professional Training at IGNFA, preceded by a 4-month Foundation Course at Lal Bahadur Shastri National Academy of Administration, Mussoorie (LBSNAA). The Professional Training for IFS Probationers at IGNFA is imparted mainly by the Faculty Members consisting of IFS officers drawn on deputation from various States and Union Territories after having served in the field for a considerable period.

To keep the Probationers abreast of the latest technologies and developments, invited experts from various reputed institutes and organizations, including non-governmental organizations, officers serving in Central and State Governments, etc., provide input on various topics and specialized aspects of forestry.

## Mid-Career Training Programme (In-Service)

The Advance Forest Management Course, became a regular feature of the Academy training calendar in 2000. These courses were a part of the Ministry of Environment & Forests, Government of India's efforts to induce attitudinal changes among forest officers to achieve the objectives set in the National Forest Policy, 1988. Such courses were meant for officers at 10, 17, and 21 years of service, coinciding with executive, supervisory, and policy levels. Hence, these courses' design helped the participants orient themselves to suit the job requirements at the respective levels.

The Indian Forest Service (Pay) Rules have been revised vide Notification No. 20011/ 1/2006-AIS-II dated February 21, 2008. Its amendment through the IFS (Pay) Second Amendment Rule, 2008 vide Notification No.14021/3/2008-AIS-II dated September 27, 2008 made the MCT programmes compulsory for awarding Junior Administrative Grade and further increments respectively to the concerned officers.

The MCT programme is compulsory as per the IFS (Pay) Rules 2008, and the MoEF&CC bears all the training expenses. From 2009 to 10, the In-Service Training was conducted in three phases, i.e., Phase III of the programme for IFS officers of 7-9 years, Phase IV for 16-18 years, and Phase V for 26-28 years of seniority.

Presently, the Mid-Career Training programme is reorganized for officers of 7 to 9, 14 to 16 and 26 to 28 years of seniority, respectively, following the rules approved by the DoPT vide D.O. No. T-1012/14/2015-Academy Desk dated May 03, 2016, and the MoEF&CC vide E.No. 12-10/2019-RT dated June 13, 2019.

As per the present scheme, Phase III lasts four weeks with a domestic tour component, Phase IV lasts four weeks with a one-week foreign component, and Phase V lasts two weeks. About 60 officers are nominated for each course and trained on a modular basis, covering general management, line ministry exposure, tour components, and the forestry module. In the case of the Phase V programme, the Management Module and Forestry Module, which are one week long, are conducted.



#### Professional Skill Up-Gradation Course

Apart from direct recruitment to the Indian Forest Service through UPSC, the induction into the Indian Forest Service is also done by promoting the State Forest Service officers.

The Academy conducts Professional Skill Upgradation Courses (PSUC) for inducted officers. These courses last ten weeks and are designed to upgrade officers' capacity to meet the requirements of the All India Service and expose them to issues at national and international levels.



#### **Senior Foresters' Workshops**

As an annual feature at the Academy, Senior Foresters' Workshops are organized. In these workshops, IFS officers who have completed 30, 35, and 50 years of service are invited to participate, deliberate, and share their experiences on emerging issues in forestry. These workshops also allow the young Probationers to interact with the senior officers.



#### PATTERN OF PROFESSIONAL TRAINING COURSE

Officers in the IFS are recruited through a national-level competitive examination conducted by the Union Public Service Commission (UPSC) every year. Only science and engineering graduates are eligible to appear in this examination. The selection procedure involves a written examination followed by an interview of successful candidates, a medical examination and a walking test of 25 km (for men)/14 km (for women) to evaluate their physical stamina.

The selected candidates undergo nearly two years of training. During this period, they are first sent to Lal Bahadur Shastri National Academy of Administration, Mussoorie, to attend the 14-week 'Foundation Course' with other All India Services and Group A Civil Services members.

After completing the Foundation Course, the IFS Probationers join Indira Gandhi National Forest Academy (IGNFA) at Dehradun, where professional training is imparted for 16 and 1/2 months. During this training, the Probationers are exposed to various core forestry and related subjects. Besides this, input on personality development and national and regional languages are also provided to probationers. About 24 technical subjects related to forestry, wildlife, environment, management, administration, law and social sciences are covered. Apart from the sessions in the Academy, the tours and exercises form an essential part of their curriculum.

Professional training of the IFS Probationers includes five tours to different parts of the country and one overseas tour on forestry practices. During these tours, they are exposed to the best management practices in forestry, wildlife, environment and related disciplines in various States and Union Territories. They witness the synergy between the local communities and forests, and such tours give them practical insights into the country's diverse socio-economic and cultural milieu. The attachments to the premier institutions of the country like (i) Parliamentary Research and Training Institute for Democracies for Parliamentary Attachment, (ii) Indian Military Academy, Dehradun for weapon training, equitation and Swimming, (ii) Indian Institute of Management for Management Module and (iv) Sardar Vallabhbhai Patel National Police Academy, Hyderabad for Forest and Wildlife Crime Detection Exercise is done during the professional training.

After completion of the professional training at the IGNFA, the Probationers join their respective allotted State cadres to discharge the duties allotted to them after an 'On the Job Training' (OJT) for four months.

The Academy follows a counsellor system wherein Probationers are assigned to different Faculty members to counsel them on professional and personal issues.

#### Training of 2021-23 Course

The Professional Training Course (IFS 2021-23 Course) of 72 Probationers of the Indian Forest Service (R.R.s of 2021 Batch) and 02 Foreign Trainees from the Royal Government of Bhutan at IGNFA commenced on March 25 2022 and concluded on August 11 2023.

After completing the Foundation Course at LBSNAA, Mussoorie held from December 05 2021 to March 17 2022, 46 IFS Probationers and 02 Foreign Trainees from the Royal Government of Bhutan joined the 53rd Professional Training Course at IGNFA on March 25 2022.

26 IFS Probationers joined the Professional Training Course at IGNFA directly on March 25 2022, with the permission of the MoEF&CC, Govt. of India.

07 of the 74 IFS Probationers resigned midway

through the first training phase on different dates in August 2022 to join other services, having been selected in the Combined Civil Services Examination CSE 2021 conducted by the Union Public Service Commission.

As such, 67 IFS Probationers/Bhutan O.T.s have continued till the end of the financial year 2022-23. The details of the allocated cadre and status of completion of the Foundation course of 2021 Batch have been attached (Annexure-III).

During the Professional Training Course at IGNFA during financial year 2022-23 the training components as per the prescribed curriculum of the Indian Forest Service (Probationer's Final Examination) Regulations 2016 under the IFS (Probation) Rules, 1968, were completed.



#### **GLIMPSES OF THE TOURS**

#### Introductory Tour

The Introductory Tour of the 2021-23 Course was held from April 15 to April 22 2022. The objectives of the tour were:

- 1. Familiarization with flora and fauna.
- 2. Biotic and abiotic factors affecting flora and fauna.
- 3. Study of forest administrative and management units.
- 4. Forest and Wildlife Management.
- 5. Familiarity with various forestry operations like logging, resin tapping, etc.
- 6. Community participation in forest protection.
- 7. Soil moisture conservation work, fire control, etc.

The Probationers visited Kanasar, Uttarakhand. During the tour, Shri Amit Kumar, Associate Professor, and Shri Tulsi Das, Associate Professor, accompanied the Probationers.

#### Thematic Tour I - Hill and Mountain Tracts Study Tour

The first thematic tour was conducted from May 15 to June 01 2022, and the objectives of the tour were:

- 1. Management of conifers and temperate broad-leaved forests.
- 2. Study of Western Himalayan Ecosystem.
- 3. Impact of Integrated Watershed Projects.
- 4. Management of Alpine Meadows.
- 5. Management of Community Resources and Private Forests.
- 6. Exposure to Wood-based Industries.
- 7. Ex-situ Conservation System & Management.

During the tour, the Probationers visited Chandigarh, Khardungla, Pangong Lake in Leh, Manali, Mohal Nature Park, Palampur, Bilaspur, Shimla and Solan. Shri Amit Kumar, Associate Professor, Shri Tulsi Das, Associate Professor and Dr Sivabala S., Associate Professor, accompanied the Probationers.



During the tour, the Probationers visited Chandigarh, Khardungla, Pangong Lake in Leh, Manali, Mohal Nature Park, Palampur, Bilaspur, Shimla and Solan. Shri Amit Kumar, Associate Professor, Shri Tulsi Das, Associate Professor and Dr Sivabala S., Associate Professor, accompanied the Probationers.



#### Thematic Tour II - Arid & Semi-Arid Zones, Coastal/Marine Ecosystem and Protected Areas in Western India in Rajasthan and Gujarat.

The second thematic tour was organized from August 16 to September 01 2022, and the objective of the tour was to familiarize the Probationers with:

- The Arid and semi-arid Bio-Geographic Zones, Forest Types, afforestation, land reclamation, drought management, Protected Areas, and floral and faunal associations.
- 2. The coastal and marine ecosystems, protected areas, floral and faunal associations
- 3. Conservation and management in Gir National Park.
- 4. Urban Forestry
- 5. Institutions associated with research and extension of forestry activities in these ecosystems.

During this tour, the Probationers visited places of importance in forestry, wildlife and environment sectors in Jaipur, Jodhpur, Jaisalmer, Ahmedabad, Kevadia, Gir National Park, Jamnagar, etc. The probationers also interacted with the PCCF and HoFFs of the states of Rajasthan and Gujarat and other senior officers. Shri Mukul Trivedi, Professor (Academics), Smt. Nidhi Srivastava, Additional Professor, Dr M Sudhagar, Associate Professor and Shri Kalunge Gorakh Waman, Associate Professor, accompanied the Probationers.



#### Thematic Tour III – Eco-restoration, People and Forest and Marine Ecosystem

The third thematic tour was organized from November 26 to December 13 2022. The Probationers were divided into two groups, and they visited the States/U.T.s as listed below:

- Group I Andaman & Nicobar Islands, West Bengal, Assam, Meghalaya and Odisha.
- Group II Andaman & Nicobar Islands, West Bengal, Assam, Meghalaya, Bihar and Jharkhand.

The objectives of the tour were to familiarize the Probationers with:

- 1. Community participation in forest management
- 2. Mining reclamation and rehabilitation
- 3. Management of Coastal Ecosystem & Marine Resources.
- 4. Management of P.A.s in Eastern and North Eastern India.

The probationers also interacted with the PCCFs and HoFFs of West Bengal, Assam, Jharkhand, Odisha, and other senior officers. Shri Mukul Trivedi, Professor; Shri Amit Kumar, Associate Professor; Dr. M. Sudhagar, Associate Professor; and Shri Kalunge Gorakh Waman, Associate Professor, accompanied the Probationers during the tour.

#### Thematic Tour IV - South & Central India and Jungle Survival Skills

This thematic tour was organized from January 12 to February 04, 2023, during which the Tamil Nadu Special Task Force organized a module on the jungle survival exercise for the IFS probationers in Sathyamangalam Forest terrain, Tamil Nadu.

During the tour, the probationers were divided into two groups, and the Jungle Survival Exercise was organized for both groups.

- = Group I Karnataka, Tamil Nadu, Kerala and Maharashtra
- = Group II Chhattisgarh, Telangana, Tamil Nadu and Karnataka




The objectives of the tour were to familiarize the Probationers with

## MoU with NLSIU, Bengaluru to Offer the Post Graduate Diploma in Environmental Law (PGDEL)



#### MID-CAREER TRAINING PROGRAMMES (MCTP)

The Academy organizes Mid-Career Training Programmes (MCTP) for Indian Forest Service officers annually. The In-Service Training programmes were started in 2000 under a project funded by DFID of the U.K. Indira Gandhi National Forest Academy (IGNFA) Dehradun, functioning as a staff college of IFS officers, was given the responsibility to conduct these In-Service programmes by the Ministry of Environment & Forest (MoEF).

Subsequently, as part of Civil Services Reforms approved by the Hon'ble Prime Minister in 2006, the MoEF approved specific changes in the ongoing pattern of Mid-Career Training courses of IFS officers to provide international exposure by including reputed national/international institutions as partner training institutions, similar to the pattern adopted by DoPT and MHA for IAS and IPS officers, respectively.

The objectives of the Mid-Career Training are as follows:

- To impart technical knowledge and skills, taking into account the latest developments in the forestry sector.
- To keep the officers abreast with the rapidly changing forest management, development and administration scenario.
- Apprise them with strategies for development and administration in the forestry sector.

#### **Course Structure**

The Course contents structure and session plans were decided per the MoEF&CC Letter No. 2-10-2011- R.T. dated 06/07/2016. The courses are conducted to cater to the functional needs of the officers and align with their expected service delivery at a particular level. Primarily, the inputs given include

#### **Training Methodology**

Considering the participants' diverse backgrounds and age profiles, the training methodology was redesigned to suit the changing needs. Salient features of the pedagogy are:

- Interactive sessions with technical analysis of various subjects
- Panel discussions, group work and exercise
- Case studies
- Experience sharing sessions by the participants
- Excursions and field visits

The Academy conducted one Phase V and two Phase III MCT programmes during the financial year 2022-23.

#### Mid-Career Training Phase- V (18th)

Mid-Career Training (MCT) Phase – V (18th) Programme of IFS officers of YoA – 1993, 1994 and 1995 (26 – 28 years of seniority) and the IFS officers of YoA – 1991 and 1992, who missed the 16th/17th Course was conducted from June 27 to July 08 2022. (Annexure-V)

#### **Objective:**

The main objective of the training was to impart knowledge about the changing environment for policy making and implementation coupled with strengthening the leadership and management skills of the officers given the complexities and ambiguities of policy processes; understanding the significant changes and major barriers in various aspects of the management of public systems, forests and forest management in India; learn about regulatory frameworks and the changing relationship of public and private sectors and civil society in the context of forestry; to help understand the requirements of a shift in the mindset and people management skills of a strategic leader and the ability to work in dynamic environments; to include skill sets of being a leader, policy maker, systemic designer, and manage conflict in addition to being a cutting-edge technocrat; to transform from being a technocrat and administrator to a visionary and chief executive of their departments with an exposure to best practices in forestry management at a national and international level. The objective was met by exposing the officers to various training programme modules.

#### **Mandatory Nature:**

The Indian Forest Service (Pay) Rules have been revised vide Notification No. 20011/1/2006-AIS-II dated 21.02.2008, and its amendment through IFS (Pay) Second Amendment Rule, 2008 vide Notification No. 14021/3/2008-AIS-II dated 27.09.2008, to make the MCT Programmes compulsory for awarding Junior Administrative Grade, IInd Super time scale and further increments respectively to the concerned officers. #### **Forestry Module:**





#### Sanjay Kumar Singh Memorial Lecture (February 15, 2023)



## S Manikandan Memorial Meeting (March 03, 2023)



#### Annual Sports 2022-23




